## Requirements

## **Articles**:

Each article is double-blind/peer-reviewed, thus exceptional rigor is extremely important. Given the number of anticipated articles, we would appreciate your article not exceeding 3000 words, but in some instances, we would consider an article of up to 6000 words.

### Interviews:

During and after the Great Depression, President Roosevelt's New Deal, which was an attempt to put Americans back to work, commenced the Federal Writers' Project (FWP). Writers, teachers, historians and journalists were commissioned to write. Some traveled the South interviewing the last of the former slaves, in their vernacular, in order to create a written, documented history of slavery from those who lived it. These slave narratives have become invaluable tools in historical, theological, sociological and ethical studies. Similarly, interviews, from those who are living in environmental or public health crises will be invaluable tools for narrative ethics, public health ethics and bioethics in future studies.

## **Student Articles:**

Undergraduate articles will be peer-reviewed as well, but not necessarily double-blind. We encourage students to publish in this very important journal edition. Students who have studied in public health, public health ethics, theological ethics and bioethics may want to make an original contribution. Of course, we cannot publish everyone, but we will publish the most original and creative works. Additionally, honorable mentions would be posted on our Bioethics website for researchers.

### Commentaries:

These writings should be limited to 10001500 words. Commentaries aren't refereed,
but they serve as an indispensable
opportunity to share a constructive critical
analysis. Know that conspiracy theories, or
any opinion lacking strong research and
academic awareness, will not be considered.
Everything you defend must be well
researched and argued. Avoid
generalizations ("Everyone is dying from
COVID-19") or other informal fallacies (straw
man, slippery slope, question begging,
missing the point, red herring, false
dichotomies, etc.) that are constructed on
weak premises or emotions.
