



## A Snapshot of the Tuskegee University College of Veterinary Medicine

- Rich history and legacy that need to be preserved yet we must prepare for the changing landscape of the veterinary profession.
- Founded in 1945 as the School of Veterinary Medicine by Dr. Frederick Douglass Patterson, the 3rd President of Tuskegee University who is a graduate of Iowa State University and achieved much in his lifetime at Tuskegee Institute (now University): founder of the School of Engineering, Tuskegee Airmen Program, Baccalaureate Degree in Nursing, The School of Veterinary Medicine, United Negro College Fund, and first Faculty member to be awarded the Ph.D.
- The first veterinary medical professional program located on the campus of a historically black college or university (HBCU) in the United States.
- Proud of our legacy and leadership in the veterinary profession by data: There are approximately 120,000 veterinarians in the U.S. and 2% are African Americans, and of that 2%, 70% graduated from Tuskegee University.
- All 7 African American deans in the AAVMC (past & present) graduated from TUCVM (Blackwell, Ferguson, Atkinson, Reed, Nelson, Perry, Gartrell).
- Recognized as the most diverse of all schools/ colleges of veterinary medicine in the U.S.
- Primary mission is to provide an environment that fosters a spirit of active, independent and self- directed learning, intellectual curiosity, creativity, critical thinking, problem solving, ethics, and leadership; and promotes teaching, research and service in veterinary medicine and related disciplines.
- Offers the professional degree of Doctor of Veterinary Medicine (DVM), the Doctor of Philosophy (Ph.D.) in Interdisciplinary

Pathobiology (IDPB) and Integrative Biosciences (IBS). The Ph.D. in IBS is also a shared degree program among the TUCVM; the College of Agriculture, Environment and Nutrition Sciences; and the College of Arts and Sciences.

 Offers the master's degree in veterinary science and the Master of Public Health (MPH).
 The Graduate Public Health program was accredited with the Council on Education for Public Health (CEPH) in 2022.







 Five (5) departments (Biomedical Sciences, Graduate Public Health, Large Animal Clinical Sciences, Pathobiology, Small Animal Clinical Sciences..

- Research program is about \$6.1M in areas of breast cancer, colon cancer, immunology, renal disease, and food safety education and training for international fellows. The college holds 3 U.S. patents on the detection of mu Multiple Salmonella serovars in meat products through the research efforts in the Center of Food Animal Health, Food Safety, and Food Defense. The College has completed a licensing agreement with a Food Supply company to commercialize GenoPATHX Salmonella detection technology for meat products.
- The veterinary complex consists of 9 buildings (Patterson Hall (Administrative building), Willams-Bowie Hall (Research building), Rosenwald, Clinical Anatomy building, Small Animal Hospital, Large Animal Hospital, H-building/Simulation Laboratory, Jr Surgery building, and a hay barn.
- The college has developed a strong industry partnership initiative to increase student scholarships with 16 industry partners and growing, that have generated over \$5M in student scholarships and support for student academic programs.
- The College has an Endowment with the HHS/ NIH/NCRR-Health and Human Services, National Institutes of Health, and National Center for Research Resources.

### **New Dermatology Suite Established in Honor** of Tuskegee Alum



The Melman Steve Foundation has designated grant funds of \$50,000 to the Tuskegee University College Veterinary Medicine (TUCVM) to honor Dr. Louis Gotthelf by establishing a Dermatology Suite in the Veterinary Teaching Hospital (VTH). The grant installment cycle began in December

2023 and will end in December 2027. The Steve Melman Foundation will not only enhance the teaching environment and clinical services provided but also promote training experiences for veterinary students. TUCVM is appreciative of the spirit of philanthropy from the grant through the Steve Melman Foundation. TUCVM also thanks Dr. Gotthelf for his contributions not only to the VTH but his role in making the Dermatology Suite a reality by sharing his vision with the Foundation.

Plans are in the works for the new dermatology suite to be located next to the dog ward in the space where the old medical records are stored once relocated. Construction is expected to begin in the next few months. The goal is for the Dermatology Suite to be used by clinicians and students in the Dermatology rotation as well as clinicians treating skin and ear cases that come through the Community Practice rotation.

"It is our hope that this unique area will be a selfcontained dermatology examination and treatment room that will have a wet prep table and adequate examination lighting. The space will contain areas for video otoscopy, laser surgery, biopsies, slide staining, a microscope station with video display, as well as the capability to do intradermal allergy testing. It will also have refrigeration and cabinetry to store drugs and shampoos used in the treatment of skin and ear diseases," said Dr. Gotthelf.

Dr. Gotthelf is a 1978 Tuskegee veterinary graduate and currently a small animal community practice clinician/adjunct assistant professor at TUCVM.

The ACVR is one of 22 veterinary specialties recognized by the American Board of Veterinary Specialties (ABVS) of the American Veterinary Medical Association (AVMA).



**Dr. Treyton Diggs '07** was honored as VETERINARIAN OF THE YEAR by the Westminster Kennel Club. This was another first for TUCVM as Dr. Diggs is now the first

African American and Louisianan to be honored with this award! The Westminster Kennel Club selected Dr. Treyton Diggs of Boutte, Louisiana as its recipient for the 2024 Veterinarian of the Year Award. In 2013, Dr. Diggs founded Allstar Animal Clinic, which specializes in soft tissue and orthopedic surgery and canine reproduction. He received training from board certified specialists in Small Animal Internal Medicine, Cardiology, Emergency and Critical Care, Neurology, Neurosurgery, Surgery, Dentistry, and Radiology.



**Dr. Kis Robertson Hale '03** was promoted to Assistant Surgeon General RADM, O-8 Grade. Selection to the rank of Rear Admiral in the U.S. Public Health Service (USPHS) Commissioned Corps is an honor that comes with great responsibility. She serves in the role of Super Office

## Tributes to Two 50 Years of Service Tuskegee Pioneering Veterinary Alumni Drs. McNamee & Morse

**Dr. George McNamee '74** is recognized as a Pioneering Veterinary Medicine Researcher, having done over 50 years of research. He wears many hats as the Deputy Director of the Surgical Simulation Center at Walter Reed National Military Center and Assistant Professor of Surgery in the Norman M. Rich Department of

Surgery at the Uniformed Services University of Health Sciences (USUHS). He mentors medical and nursing students, residents, and faculty in the proper techniques of surgery and research, leading to improvements in patient care and safety. Dr. McNamee has also been reappointed as a faculty member in the F. Edward Herbert School of Medicine as a Clinical Associate Professor of Surgery, effective October 2024 to September 2027. Dr. McNamee's journey to becoming a prominent veterinary researcher was shaped by his early experiences and a deep-rooted passion for animals. His journey led him to

Tuskegee and after graduating, he embarked on a remarkable career that encompassed myriad facets of veterinary medicine. McNamee's research encompassed a diverse array of topics, ranging from orthopedics to ophthalmology.

**Dr. Evan Morse '68** is also considered a Pioneer in Veterinary Medicine having celebrated his 50 Year Anniversary as owner of Warrensville Animal Hospital in 2022 with a special celebration. He has also been recognized by the city of Cleveland, OH, with a proclamation and golden clock acknowledging his "50 Years in the Friendly City" as

denoted in the photo above. Dr. Morse has mentored numerous students over his 50 years in practice, including most recently, Brooklyn Macklin, who is now a member of TUCVM's first-year class of 2028. Ms. Macklin worked at Dr. Morse's veterinary hospital for many years and considers him to be her veterinary mentor and to have been a major inspiration for her pursuing this dream of attending Tuskegee to become a veterinarian. Now an octogenarian, Dr. Morse was honored with a social media viral video toast from acclaimed actor and comedian Kym Whitley on August 19, 2024, for his 80th Birthday. Dr. Morse founded the Warrensville Animal Center in 1972 and was one of the first African American veterinarians in the state of Ohio and the first one in the city of Cleveland, Ohio. He is also co-founder of the Free Animal Clinic Team (FACT).



The students also visited Holleta livestock research station and the Animal Biotechnology Research Program Laboratory which also included various experiential activities.

# 63 Doctors Of Veterinary Medicine Recognized During Tuskegee University 2024 Spring Commencement, Oath and Hooding Ceremony

he Tuskegee University College of Veterinary Medicine (TUCVM) welcomed 63 new doctors of veterinary medicine into the profession on May 4 during the Graduate and Professional Schools formal ceremony in the Chappie James Arena. However, it was the Veterinary Medicine Oath and Hooding Ceremony which followed the commencement that held the most excitement for the graduates as they formally took their oath as now official veterinarians in front of family and friends.

The veterinary medicine class of 2024 represents the 75th graduation class of veterinarians from Tuskegee University. Since 1949, Tuskegee has now awarded over 3,000 veterinary medicine degrees from the only veterinary medical professional program on the campus of a Historically Black College or University.

"The College of Veterinary Medicine family is extremely proud of each graduate, and we look forward to hearing about the accomplishments they will make as veterinary professionals, as leaders, as educators, and as researchers," said Dr. Ruby L. Perry, dean of the College of Veterinary Medicine during the oath and hooding ceremony. "They are well-equipped to make significant contributions and play vital roles in protecting and enhancing human and animal welfare as they embark on their various career paths on a journey of lifelong learning beyond the DVM degree. Congratulations Class of 2024!"

Each year a veterinary professional delivers the challenge address to the veterinary graduates. This year the Veterinary Medicine Oath



keynote speaker was Tuskegee Veterinary alumna Carla Gartrell, DVM, JD, DACVIM. Dr. Gartrell, an '88 graduate, gave an uplifting Veterinary Medicine Oath Charge to the newly named doctors of veterinary medicine. She is the seventh veterinary alum from Tuskegee University to be appointed as dean in the American Association of Veterinary Medical Colleges (AAVMC).

Dr. Gartrell was appointed as the dean at Midwestern University College of Veterinary Medicine located in Glendale, Arizona, in 2022. She received both her B.S. and Doctor of Veterinary Medicine (DVM) degrees from Tuskegee University in 1988. Prior to becoming dean at Midwestern, she previously held the faculty and administration positions of Associate Professor and the Associate Dean for Academic Affairs and then promoted to Professor and Associate Dean for Clinical Affairs. She is Board-certified by the American College of Veterinary Internal Medicine and is a member of the American Veterinary Medical Association, American Bar Association, and the Arizona Veterinary Medical Association.

During Dr. Gartrell's presentation to the new graduates, she spoke on three stories that made a profound difference in her journey as a veterinarian. She summarized the following six core principles that all begin with the letter "C" for the graduates to embrace in her challenge to them: "1. Compassion – be compassionate and care deeply, 2. Curiosity – stay curious and committed to life-long learning, 3. Courage – be bold because you grow through what you go through, 4. Community – you are a vital part of a larger community so be involved in it, 5. Champion – be a champion for yourself, your patient and others, and lastly, 6. Celebrate – you have earned this moment so embrace your journey to get here and look forward to your futures, " Dr. Gartrell said.

Dean Perry also recognized five TUCVM Distinguished Alumni Awards recipients during the veterinary medicine oath ceremony program. This year's honorees included:

**Dr. Carla Gartrell '88**, Veterinary Medicine Oath Speaker and 2nd Tuskegee veterinary medicine alumna appointed dean of U.S. veterinary school; Dr. James "Jim" Heintz, Sr. '73 (posthumously), former TUCVM faculty member who served in private practice for 32 years before transitioning to academia as a result of Hurricane Katrina. Dr. Heintz dedication to his alma mater remained steadfast throughout his career serving as President of the Tuskegee (then School) of Veterinary Medicine Alumni Association, serving on the Tuskegee Veterinary Medical Alumni Association (TVMAA) Executive Council, and being recognized for his enduring support of Tuskegee as a prestigious Presidential Associate Award recipient;

**Dr. Charles Lowrie '72**, a dedicated veterinarian with over 26 years of service as a general practitioner with a referral focus in neurology and neurosurgery, then serving in academia as the Clinical Neurologist and Neurosurgeon at the College of Veterinary Medicine at Michigan State University until retiring in 2002 as a professor emeritus. Also a previous president of the TVMAA, Dr. Lowrie is most notably recognized for his work in co-facilitating clinical experiences for aspiring veterinary students in the Vetward Bound program and providing counsel and support for Tuskegee graduates completing their Post-DVM training at MSU;

**Dr. David Negola '72**, a seasoned veterinarian with over 50 years of experience, created and owned

several private practices as well as mentored and/ or employed multiple talented individuals who he recommended to Tuskegee for veterinary school. Through his mentorship, these individuals have prospered and gone on to own practices themselves all over the country. Dr. Negola's commitment to Tuskegee has also led to his service on the Dean's Advisory Board and receiving the Presidential Associate Award for financial support to the school/college since graduation; and

**Dr. Richard Savino '72**, a dedicated small animal companion veterinarian who retired in 2020 after giving 48 years of service to the profession and his alma mater. He was previously honored with the Presidential Associate Award for his dedication to his beloved alma mater and he treasures the profound impact Tuskegee has had on his life. Dr. Savino has served on the Dean's Advisory Board, the Alumni Executive Board, co-chaired the Minority Recruitment Committee striving to promote diversity and inclusion, and contributed to the development of the alumni association's (TVMAA) website, ensuring that the bonds endure beyond graduation.



On Historic honors for Tuskegee veterinary alumni are nothing new and this was once again noted during the 2024 American Veterinary Medical Association (AVMA) Convention held in Austin, Texas, June 21-25. Dr. Ruby L. Perry, '77 veterinary alumna and dean of the Tuskegee University College of Veterinary Medicine, was honored with the AVMA's Lifetime Achievement Award. Dr. Michael Q. Bailey, '82 veterinary alumnus, was elected the first Black president-elect for the AVMA. Both Dr. Perry and Dr. Baily are board-certified veterinary radiologists in the American College of Veterinary Radiology. Dr. Perry is also noted as the first African American female board-certified veterinary radiologist.

Dr. Perry was named the second recipient of the 2024 AVMA Frederick Douglass Patterson Lifetime Achievement Award for her distinguished leadership in advancing Diversity, Equity, and Inclusion (DEI) throughout the veterinary profession. The award was presented to Dean Perry on Friday, June 21. The AVMA's first recipient last year was also a Tuskegee veterinary alumnus, Dr. Willie Reed.

Dr. Janet Donlin, the AVMA's Executive Vice President and CEO, gave accolades for the selection of Dean Perry for this award. "Over the years, you (Dr. Perry) have set a benchmark for excellence. Much like Dr. Frederick Douglass Patterson, Dr. Perry has been a beacon of hope and guidance through her mentorship of underrepresented groups and has also exemplified unparalleled leadership across various veterinary committees and organizations. Steadfast commitment has allowed her to bring about meaningful change in the veterinary profession," Dr. Donlin said.

"Upon learning of my selection as the 2024 recipient of the AVMA Frederick Douglass Patterson Lifetime Achievement Award, I was humbled and extremely honored to be the second recipient of this award following my colleague and fellow Tuskegee veterinary alum, Dr. Willie Reed. Dr. Patterson was a profound man in the history of Tuskegee University and specifically in the establishment of the veterinary medical program as well as a visionary leader," Dr. Perry said.

Also on June 21, Dr. Bailey was named the AVMA's first Black president-elect for 2024-25 by the AVMA House of Delegates (HOD). He will begin serving his term as the Association's president when current president Dr. Sandra Faeh's term expires in July during the AVMA Convention 2025 in Washington, D.C.

Bailey currently works for IDEXX Laboratories as a veterinary radiologist and medical director. He pioneered Ohio's practice private inaugural advanced veterinary CT imaging services and launched referral and emergency imaging facilities in Pittsburgh. Dr. Bailey also currently serves as the director of medical innovations in telemedicine for a global telemedicine consultant business, where he brings his extensive telemedicine expertise to the forefront. Previously he served on the veterinary faculties of Michigan State University, The Ohio State University, and Tuskegee University.

In speaking to the HOD on June 21, Dr. Bailey pledged to offer "robust, effective, and diverse leadership that inspires innovation."

Dr. Bailey emphasized the importance of

AVMA members. He said, "You are not just part of the AVMA. We, the members, are the vital symbionts a diverse and dedicated community that sustains and grows our AVMA."

Also worth noting, with the election of Dr. Bailey as the AVMA president-elect, Tuskegee University will have two veterinary alumni to have served as president of the AVMA. Dr. Theodore (Ted) Cohn, '75 veterinary alumnus, served as AVMA president from 2014-15.

The Buffalo Soldiers of Atlanta group had expressed last year their desire to make this an annual event and to bring even more of their members and horses for the next visit to TUCVM.

TUCVM's large animal clinicians were happy to treat the horses of the 10th Cavalry Troop A (Buffalo Soldiers of Atlanta) on Saturday October 26, 2024. This visit was planned and facilitated by TUCVM's Dr. Steven Walker, Assistant Professor of Small Animal Community Practice.

Dr. Walker was assisted by: Dr. David McKenzie (Professor/Associate Dean for Clinical Programs and Large Animal Clinical Sciences Department Head), Dr. Courtney Allred (Clinical Instructor, Large Animal Medicine and Surgery), and two large animal interns along with TUCVM's inhouse and ambulatory students.

Six members of the Buffalo Soldiers of Atlanta brought eight of their horses for full examinations including physical examinations, fecal exams and deworming, vaccinations, and Coggins testing. However, three of the horses were recently exposed to leaked gas from the plant incident in Georgia so baseline bloodwork was also done on these horses to check for any toxicity. Fortunately, all three horses were cleared.

The group also posed for pictures in their period cavalry uniform or official t-shirts with TUCVM's faculty and students. The group also gave the faculty t-shirts and information about the organization and expressed great pleasure with their second visit to TUCVM and the

hospitality they received as well as the treatment they received for their horses.

"The Greater Atlanta 9th & 10th Buffalo Soldiers Chapter is making bigger plans for the future in hoping to organize a trail ride with TUCVM included. This will involve training on horses like a mini horse health fair. This will also be a great teaching time for our students and help increase accessions through the treatment of many more Buffalo Soldiers' horses," Dr. Walker said.

## TUCVM Faculty Instrumental in University Receiving Breast Cancer Research Support

TUCVM's **Dr. Deepa Bedi** is once again using her platform as a scientist to support ongoing breast cancer research at Tuskegee University. Dr. Bedi is Tuskegee's principal

investigator and an Associate Professor of Biomedical Sciences at the Tuskegee University College of Veterinary Medicine. Tuskegee University will share \$1.1 million from the Breast Cancer Research Foundation of Alabama to support ongoing breast cancer research. In partnership with Auburn University, Tuskegee is one of 22 research projects at seven institutions across the state that will share the funding.

"Tuskegee University is partnering with Auburn University on the research to leverage each institution's strengths," Dr. Bedi said. She is collaborating with Auburn University's Dr. Maninder Sandey.

"We are deeply committed to making a meaningful impact on breast cancer research, with a particular focus on addressing health disparities in underserved communities," said Dr. Bedi, who holds a patent for her breast cancer research. "My passion lies in empowering our students to engage in transformative science that not only advances knowledge but also directly improves lives. By involving students in initiatives like this one, we aim to inspire the next generation of researchers, ensuring they understand the significance of their contributions to addressing a disease that affects millions. My hope is that through their involvement, students will carry forward the values of innovation, community service, and scientific excellence to create a legacy in the fight against breast cancer."
