On – Campus ACT (Residual)

Tuskegee University offers On – Campus ACT test (Residual). The ACT On-Campus is an alternative to the ACT test that enables Tuskegee University to proctor and score an ACT test on campus. Testing is only provided to prospective students seeking admission, have enrolled, or who have been admitted to Tuskegee University. ACT On-Campus scores are only valid at Tuskegee University and cannot be released or transferred to another institution. The On-Campus ACT consists of **English, Math, Science** and **Reading**. Scores from this Residual ACT are reported to admissions or your advisor.

General Information:

The test is approximately 3.5 -4 hours long.

Test 1- 45 minutes

Test 2- 60 minutes

Break- 15 minutes

Test 3- 35 minutes

Test 4-35 minutes

- Only students who have been or will be admitted can register to take the **On-Campus (Residual) ACT test**.
- This test will not transfer to a four-year school. This test is meant for placement purposes or entrance into Tuskegee University. This test cannot be transferred by transcript or other means to any other institution or agency.
- No Student Reports and no High School reports are generated.
- ACT On-Campus scores are not scored by ACT and, therefore are not official transferable scores like those provided by the ACT National Test.
- **Paper based test**
- Exams are hand scored; you will be emailed a copy of your scores on Tuskegee University Letterhead for your records.
- The Residual ACT testing year runs **November 1-September 30**. More information is available on the [ACT Website](#).

- \$50.00 registration fee (non-refundable) must be paid online (credit / debit) before your exam appointment.

Eligibility:

- Tuskegee University admission application must be on file with Tuskegee University for the upcoming semester or
- Tuskegee University enrolled student.
- A 60-day minimum must elapse from the last On - Campus ACT taken.

If you register and do not meet eligibility requirements, you cannot register for the On- campus test.

Test Day:

Arrive early. You will not be admitted to the testing room once the test has begun.

Upon arrival for testing, you must have the following:

- Unexpired government issued **photo ID**, such as a driver's license (will not accept photocopy or picture on cell phone). Bring an ID with a photo and signature (driver's license, state ID, passport, school ID).
- TU student ID (*if applicable*).
- Number 2 pencils.
- ACT approved calculator. Check your calculator [here](#). Approved calculators will be allowed in the math portion of the test. Calculators are not provided.
- Cell phone use is restricted during testing and must be turned off.
- Food & Drinks will not be allowed in the testing rooms.
- Your test session will be monitored.
